Our efforts would have been diminished without the assistance of Robert Singerman and the <u>Singerman Bibliography of Antisemitic Texts in English</u>, a new subscription database developed out of his 1982 book, *Antisemitic Propaganda: An Annotated Bibliography and Research Guide*. That work consisted of 1,915 entries and has now been expanded to 9,200+ searchable entries. I'm honored to serve as the database's co-editor. All of the items in this catalog may be found in the new database save for a couple which are so noted.








1.) Drumont, Édouard. La France Juive: Essai D'Histoire Contemporaine (Édition Illustrée de Scènes, Vues, Portraits, Cartes et Plans). Paris: Librairie Blériot, [1887]. \$450

A special illustrated edition of one of the most notorious French anti-Semitic works, which was the most widely read book in France upon its release in 1886. A three volume illustrated edition was published in 1887 quickly followed by an abridged one volume, illustrated edition "designed by Drumont to reach the peasant and worker" (Byrnes, p. 180). This is a copy from that edition.

2.) [Timayenis, Telemachus Thomas]; J. B. Stoner (introduction). The Original Mr. Jew: A Startling Expose. Savannah, Georgia: The Thunderbolt, Inc., [196-?]. Reprint. SOLD

Originally published in 1888 as *The Original Mr. Jacobs: A Startling Exposé*, this reprint was undertaken by the National States Rights Party during the 1960s and was published under the less subtitle title, *The Original Mr. Jew: A Startling Expose*. In his introduction, J. B. Stoner explains, "The Thunderbolt decided to republish [this book] so that the Jews and how they carry on their operations against the White Race can be better understood. It is our duty to publish this book for the benefit of the White Aryan Race in America and throughout the world."

The Original Mr. Jacobs was the first of three viciously anti-Semitic books written in quick succession by the Greek expat, professor, playwright, businessman, and tutor to the children of some of America's wealthiest families, Telemachus Thomas Timayenis (1853-1918). In The Original Mr. Jacobs, Timayenis borrows liberally from Édouard Drumont's best-selling La France juive (1886) to paint an unflattering picture of the Jew throughout history. He employs nearly every derogatory stereotype of Jews characterizing them as vulgar, unhygienic, unscrupulous, usurious, unoriginal, cannibalistic and always as "that hideous bird that installs itself in the nest constructed by another."

He followed up *The Original Mr. Jacobs* with *The American Jew*, a more grossly anti-Semitic work that was even more vicious and spurious, although he constantly claimed to be "dealing with facts." In a *New York Times* interview following the publication of *The American Jew*, Timayenis claimed to have sold over 200,000 copies of *The Original Mr. Jacobs*, and maintained that following publication of *The American Jew*, he'd received six death threats a day from Jews, since [the letters] "evince a cowardly Jewish spirit." He wrote one final anti-Semitic work in 1889 titled *Judas Iscariot* and then went on to edit a Greek language newspaper, *The Eastern and Western Review* before dying indigent in Tewksbury State Hospital outside Lowell, MA, in 1918.



3.) Pranaitis, Rev. I. B.; E. N. Sanctuary (ed.). The Talmud Unmasked: The Secret Rabbinical Teachings Concerning Christians. New York: E. N. Sanctuary, 1941. Second English language edition. \$175

The second English language of *Christianus in Talmude Iudaeorum*, an anti-Semitic pamphlet authored by the defrocked Lithuanian priest, Justinanus Bonaventura Pranaitis (1861-1917), and first published in Latin in 1892. After an introduction and overview of the Talmud, Pranaitis divides the book into two sections: 1.) The Teachings of the Talmud Concerning Christians, in which Christ and Christians are discussed with scorn and contempt and 2.) Precepts of the Talmud Concerning Christians, in which Christians are to be avoided and exterminated. In 1913, Pranaitis was brought as an expert witness in the infamous Beilis trial, in which a Jew, Menahem Mendel Beilis, was arrested for the murder of a child and accused of ritual murder. Pranaitis proved less-than credible and displayed ignorance of simple Talmudic concepts. He was reportedly killed during the Bolshevik Revolution.

The noted anti-Semite, Col. E. N. Sanctuary, edited and published the first English language edition in 1939, in which he added an Appendix titled, "How the Popes Treated the Jews." In this second edition, he includes a 17-page rebuttal - citing Arnold Leese extensively - to Ben Zion Bokser's article in the Contemporary Jewish Record, "Talmudic Forgeries, A Case Study in Anti-Jewish Propaganda." Sanctuary's translation was responsible for a slew of excerpts found in other anti-Semitic publications that reprinted Pranaitis' spurious claims. The National States Rights Party reprinted the book in 1964, although all of Sanctuary's commentary was omitted.

Perfect-bound wrappers (8 ½" x 5 ½"), 111 p. This copy was distributed by Sanctuary's contemporary, William Kullgren, and includes his stamp to the front cover. The covers were bound upside down and Appendix II was erroneously bound upside down and at the beginning of the book instead of the end. Still, a very scarce copy of the most expanded edition of this infamous anti-Semitic work. (10034)





4.) [Banister, Joseph (ed.)]. Jewry Über Alles [Hidden Hand] (28 issues + index). London: The Judaic Publishing Co., Ltd. / The Britons, 1920-1923. SOLD

A significant run of one of the most unabashed anti-Semitic journals of the 20th century, which was published by the Britons between 1920-25 under three different titles: *Jewry Über Alles* (Feb. 1920-Aug. 1920), *The Hidden Hand or Jewry Ueber Alles* (Sept. 1920-April 1924), and the *British Guardian* (May 1924-June 1925). The Britons launched the journal 8 months after their founding on July 18, 1919 to "plead the cause of England against her usurping [Jewish] overlords" (from issue 1). Early issues featured a cover illustration by "Goy" (the pseudonym of Richard T. Cooper, a founding Britons member and later its president) that included a stereotypical Jewish physiognomy with tentacles of industry touching every continent. A few of the issues include inserts of similarly themed Goy cartoons.

The journal, which was anonymously edited by Joseph Banister, reported on the activities of the Britons and other British and international anti-Semitic organizations (including a

growing collaboration with German anti-Semities), but its primary focus was on exposing the Jewish "hidden hand" in all aspects of British economic, political, religious and social life. Each issue also featured adverts for the Britons growing body of literature, including the *Protocols*, which they became the primary distributor of after purchasing the plates from Eyre & Spottiswoode for £30 in 1920. Our run includes these 28 issues + an index for Vol. II: Vol. 1, Nos. 1, 3, 5-12; Vol. II, Nos. 9, 12, Vol. II - Index; Vol. III, Nos. 1-9; Vol. IV, Nos. 1, 4, 6-10. No issues of the *British Guardian* are included in this run.

Single-stapled wrappers (9 ¾" x 7 ½"), each issue 8 p., some illustrated. Most issues are VG to Near Fine. One issue damp-stained, most with staple bleed, one issue lacking staple; Britons stamp to the front of a few issues.



5.) [Beamish, Henry Hamilton]. The Jews' Who's Who. Israelite Finance. Its Sinister Influence. London: The Judaic Publishing Co., 1920. First edition. \$1,200 (ON HOLD)

Although unattributed, *The Jew's Who's Who* was written by Henry Hamilton Beamish (1873-1948), founder of the Britons Society and one of England's most obsessed anti-Semites. The book is described as "a call to all true Englishmen to rouse themselves and to eradicate the International alien influences which are swiftly and surely crushing the very life-blood out of this great Empire of ours." The book was initially published by Beamish's Judaic Publishing Co., which

was renamed The Britons Publishing Co. in 1922. As Nick Toczek observes, the book is "nothing more or less than a reference work for the Jew-fixated" (p. 85). The majority of the book is a detailed compendium of Jewish-owned financial interests and net worth, but also includes a timeline of "The Jew Conquest of England," a list of Jews who Anglicized their names, many Semitic and anti-Semitic quotes, and calls for Britains to join the Britons Society. Beamish would later become vice president of Arnold Leese's Imperial Fascist League leaving him a sizable bequest that would help underwrite British anti-semitism for years following his death in Rhodesia in 1948. An important, if scurrilous, anti-Semitic publication rarely seen in commerce.

6.) Rosenberg, Alfred. Der staatsfeindliche Zionismus [Zionism: Enemy of the State]. München: Zentralverlag der NSDAP, Franz Eher Nachf., 1943. Fourth edition. \$175

First published in 1922, Rosenberg, the Nazi Party's chief ideologue, argues that Zionism is both an enemy of the German state and a political ploy by Jewry in its aim for world domination. This sentiment was later echoed by Hitler in *Mein Kampf*.

7.) Jürgens, Jens (pseud.). Die entdeckten "Henker und Brandstifter der Welt" und ihr 2000 jähriges. Verschwörungssystem. Der Schlüssel zur Weltgeschichte und Weltpolitik. Aus Geheimarchiven und Bekenntnissen von einem Eingewihten [The Discovered Executioners and Arsonists of the World and their 2000-Year Conspiracy System: The Key to World History and World Politics. From Secret Archives and Confessions from an Insider]. München: Fortschittliche Buchhandlung, 1928. \$175

A booklet from the teacher, anti-Semite and conspiracy theorist Karl Weinländer writing under one of his numerous pseudonyms. Included are some of the caricatures of prominent Russian Jews originally published from cartoons by Otto von Kursell in *The Gravediggers of Russia* (The German People's Publishing House, 1921), as well as other illustrations of allegedly Jewish popes. A bizarre book. Weinländer was later sidelined by the Nazis for being too eccentric.

8.) Ravage, Marcus Eli. A Real Case Against the Jews / Commissary to the Gentiles. [Bremerton, WA?]: [American Publishing Society?], [ca. 1939]. SOLD

A pamphlet reprinting two satirical articles by the Romanian Jew, Marcus Eli Ravage, on Jewish subversion of white, Gentile culture. "A Real Case Against the Jews" and "Commissary to the Gentiles" were originally printed in the January and February issues of *Century Magazine* (1928), and then reprinted and distributed by the Nazi Party and other anti-Semitic groups as proof of "International Jewry's disintegrating work, destructive in this case to our Aryan Christian Culture" (from the preface of a different edition; see item). The front cover features an illustration of a caricatured Jew leading a Gentile like cattle. The rear cover features the spurious anti-Semitic quote atttibuted to Benjamin Franklin.


Although apparently distributed by the Deutscher Fichte-Bund, the German propaganda agency, based on a notation at the top of the first page ("Recd from Deutscher Fichte-Bund, Hamburg, Nov. 1939. Via Italian"), Singerman ascribes publication to the American Publishing Society in Bremerton, WA, the publisher of the notorious pamphlet, *Why Are the Jews Persecuted for Their Religion?* (see item <u>30</u>).



9.) Ravage, Marcus Eli. "Bombshell Against Christianity!: Articles by: Marcus Eli Ravage, a Hebrew. Erfurt, Germany: World Service, [193-]. SOLD

An English language pamphlet distributed by the Nazi Party's propaganda agency World Service reprinting two satirical articles by the Romanian Jew, Marcus Eli Ravage, on Jewish subversion of white, Gentile culture. "Real Case Against the Jews" and "Commissary to the Gentiles" were originally printed in the January and February issues of *Century Magazine* (1928), and then distributed by the Nazi Party and other anti-Semitic groups as proof of "International Jewry's disintegrating work, destructive in this case to our Aryan Christian Culture" (from the preface, p. [3]).

10.) The Brother, XII. The End of the Days. Nanaimo, B. C.: The Chalice Press, [1928]. SOLD

A collection of "history-making documents" by Brother XII (Edward Arthur Wilson) that were originally published in *The Chalice*, the magazine of Wilson's Aquarian Foundation. The documents describe what Wilson coined the "Empire of Evil," a conspiracy of Jewry and Jesuitism to enslave the world. He founded a "third party" called the Protestant Protective League which saw him align himself with the Klan and other anti-Jewish/anti-Catholic elements.

Edward Wilson (1878-1934) was an English ship captain who founded the Aquarian Foundation as a theosophy offshoot in 1927. He led a spiritual community on Vancouver Island and amassed a large amount of wealth from his followers before they instigated legal proceedings against him. He fled with his mistress in 1932 and purportedly died in Switzerland in 1934, although the circumstances around his death are disputed.

A primer of German anti-Semitic propaganda discussing the Jewish role in ritual murder, prostitution, international finance, Freemasonry, etc. Originally published in Germany in 1930, this edition was reprinted by George Dietz's White Power imprint in the original German fraktur.

FOREWORD.

THE above title is intended to be provocative, to compel attention; to drive men even to anger so long as it causes them to demand the reason for such an extraordinary heading. If they read this Paper they will learn that unless we all pull ourselves together and take notice of the Power that is tampering with the fate of civilised nations, we shall all have to salute the Jews as our masters. They will learn from the Evil Power's own statements what objects it has in view and by what methods they are being attained. WORLD DOMINATION BY THE JEWS. IMPENDING SUCCESS OF THE SCHEME.

CHAPTER I.

- 1. Eighteen hundred or 2,000 years ago the Jews decided that some day they would dominate the whole world. Their writers and speakers of to-day frequently admit that this is still their intention. For instance, at the Zionist Congress of 1898 one of the speakers said that "the Jews ching firmly to their historic hope of world empire." Note the word "historic."
- 2. Seeing that there are only 16 million Jews in the world and 1838 million non-Jews, the idea may appear to the casual observer to be fantastic. But any appear to the casual to dig a very short way below the surface can establish the fact that not only does this scheme exist, but, unless something miraculous occurs, there is nothing to prevent it arriving at a successful issue. 


13.) Keep Out Alien Jews. [London]: British Union, [193-?]. \$200

An early British Union of Fascists handbill advertising a series of meetings to address "alien Jewish immigration into Britain." Featured speakers include Mick Clarke (one of the BUF's leading orators), [Joan] Morgan (the British film star), [Thomas Waller] Cooper (who would go on to fight with Germany as a member of the SS) and ['Harry'] Hatton (a Catholic jellied-eel stall owner).


14.) Queenborough, Lady (Edith Starr Miller). Occult Theocrasy [2 volumes]. [Abbeville (France)]: [Imprimerie F. Paillart], [1933]. First edition. SOLD



An exhaustive work by the American socialite, Lady Queenborough, Edith Starr Miller (Paget), on the various political, philanthropic and occult groups manipulated by a small group of international Jewish financiers who seek to erode Christian civilization. Inspired by the ouevre of her contemporary, Nesta Webster, Miller's conspiratorial thread links the Masons with the Ku Klux Klan and Sinn Fein and innumerable other organizations and tendencies. In "Judaism, The Pharisees" and "Rite of Mizraim," she discusses the Jews more specifically. In the former, she maintains that through the "practical application of Cabalist knowledge" the Jews gained influence and power in "higher spheres of Gentile life and over the masses." This influence led to the attainment of political and financial power through the manipulation of state funds and taxes by Jewish financiers. She then traces the schisms between various Jewish sects, the anti-Gentile basis of the Talmud and the exposé of Jewish aims outlined in the Protocols. The Protocols are discussed more fully in "Rite of Mizraim," where she provides its publication history, a short sketch of Maurice Joly, the anonymous author of the political satire, The Dialogue in Hell Between Machiavelli and Montesquieu (1864), later used as a basis for the Protocols, and the Masonic activities of the Jew, Adolphe Crémieux. In her conclusion, Miller maintains that all secret societies serve a political purpose largely unknown to the majority of their members, that their power is real and international in scope, and that their aims all concern the concentration of power wielded by a small group of Jewish financiers who each control a branch of the International conspiracy. Miller was allegedly aided in her research by the noted anti-Semitic propagandist, Leslie Fry.

Lady Queenborough, Edith Starr Miller (1887-1933), was a Rhode Island born socialite who married Almeric Hugh Paget, 1st Baron Queenborough in 1921. The Pagets settled in England where they fraternized with a coterie of high society fascists. Miller allegedly spent ten years researching and writing Occult Theocrasy, and although she finished it in 1931 it wasn't until her death in 1933 at the age of 45 that it was published under the auspices of the unknown International League for Historical Research.






15.) Roth, Samuel. Jews Must Live: An Account of the Persecution of the World By Israel On All the Frontiers of Civilization. Birmingham: National States Rights Party, 1964. Reprint. \$150

In 1964, the National States Rights Party was the first to reprint Samuel Roth's controversial anti-Semitic work, Jews Must Live (1934). Roth was a Jewish publisher and pornographer who blamed the demise of his publishing venture, William Faro, on fellow Jews. He relates this tale in one of the two chapters inexplicably omitted from this edition (the other being "Do Jews Emit a Peculiar Odor?"), and used the experience to expound more generally on Jews as they "pursue vain, greedy careers as lawyers, physicians, money-lenders, merchants, gangsters; as citizens of a country and of the world; as actors and theatrical managers; as conductors of brothers, licensed and unlicensed; as social climbers confusing and belittling all fine social standards; also as Zionists following a hastily dyed banner." Through the book he advances the Jewish tropes of parasite, vulture, shyster, exploiter and culture distorter and justifies Jewish pogroms as "the climax of years of relentless goading" (by Jews). One of the foremost examples of literary self-hatred and a godsend for future generations of anti-Semites. The NSRP changed the sub-title of the book from "An Account of the Persecution of the World by Israel On All the Frontiers of Civilization" to "Secrets of Sharp Jewish Business Practices Revealed," but importantly, they included the 11 illustrations by John Conrad that appeared in the original edition. Included is the NSRP's hyperbolic advertising mailer for the book.

16.) Leese, A. S. Bolshevism Is Jewish! London: Imperial Fascist League, 1939. Second edition. \$150

In this pamphlet, Arnold Leese contends that "Bolshevism represents one of the final stages in the deliberate Jewish programme for World Domination." He differentiates between Communism and Bolshevism, which he defines as "State Capitalism, run by Jews in the Jewish interests" (p. 3). He primarily focuses on the development of Russian Bolshevism, but he also traces its emergence in Germany, Hungary, China, and Spain where Jews were always at the helm. He concludes by summarizing: "Bolshevism is Jewish. Its object is to gain world domination for Jews, through the combined and allied forces of Jewish finance and Jewish Marxism" (p. [11]). Originally published in 1933, this is the second, enlarged edition.




17.) Leese, Arnold. Our Jewish Aristocracy: A Revelation. Guildford, [Surrey]: Arnold Leese, 1949. Fifth edition [Revised]. \$150

In this short pamphlet, the outspoken British anti-Semite Arnold Leese compiles lists of the English aristocracy who he maintains are tainted with Jewish blood. These include: 'Hereditary Title Holders with Jewish Blood'; 'Hereditary Title Holders Who Married Jewish Women; and 'Knights of Jewish Blood'. Leese concludes the pamphlet by observing, "As a result of this Jewish penetration, Britons have begun to accept Jewish-looking fellow-citizens as normal" (p. 8).

Leese published three editions of this pamphlet between 1936-1937, with a fourth edition published in his newsletter, *Gothic Ripples*, No. 31, followed by this fifth and final edition. Originally sub-titled, 'A Contamination', Leese toned down the rhetoric for this final edition, presumably to avoid any more jail time. Later republished by James K. Warner's Sons of Liberty imprint.


Arnold Leese's controversial booklet on Jewish ritual murder published after he served six months in jail for libel for anti-Semitic content in his newspaper *The Fascist*. Leese intended to use the topic of ritual murder in his courtroom defence, but the judge prohibited it. He thus compiled and published this booklet "in the public interest to break the attack on Free Speech that is rapidly developing wherever any criticism of the past or present conduct of Jews is concerned, an attack which relies for its success upon the ridiculous charge that a breach of the peace is likely if the truth about them is spoken!" (Introduction). Leese explores the Jewish racial urge for human sacrifice citing specific cases throughout history using Jewish and non-Jewish sources to support his claims. Pages 53-54 to discuss the kidnapping and murder of Charles Lindbergh's baby son as a probable case of Jewish ritual murder. Singerman calls the pamphlet, "the most extensive English-language source in support of the charge of ritual murder among the Jews" (p. 108, 0441).

This copy was reprinted in 1945 by Homer Maertz's Pioneer News Service in Chicago. On Oct. 6, 1945, Maertz attended a Christian Front rally in NYC where he was arrested along with fellow anti-Semites Ernst Elmhurst and Kurt Mertig for unlawful assembly and disorderly conduct, partly in relation to the distribution of Leese's pamphlet. The pamphlet was used as evidence against Maertz at his trial, in which the presiding judge, Henry Curran, characterized it as the "most vicious, venomous and bate-inciting I've ever seen" (ADL Bulletin for March 1, 1946). An expanded version of the first edition in which Leese refutes the many reasons provided for England's entry into WWII, maintaining that it was solely based on Jewish manipulation for self-preservation and advancement. A somewhat anomalous Leese publication at 124 pp. as the majority of his pamphlets were much shorter, including his autobiography which was only 74 pp. Initially published at the end of 1945 and according to Leese limited to a few hundred copies, this second edition appears to have been printed in the U.S. - for Leese - in 1947.

The sixth and final issue of The Britischer (also Britisher), one of three newspapers published by the Militant Christian Patriots (MCP). The MCP was founded by Col. A. H. Lane in 1929 following the publication of his book *The Alien Menace*. It began publishing the *Free Press* in 1935, which was edited by the enigmatic, peripatetic, anti-Semite, L. Fry, who founded a chapter of the MCP in Glendale, CA, in the spring of 1936. She edited and published the *Christian Free Press* (see item 21) while the *Free Press* remained in London. *The Britischer* began in 1937 as *The Britisher* (only this issue featured the different spelling) and was edited by J. F. Rushbrook, a prominent member of the Britons and the Imperial Fascist League, and editor of the *Free Press* after Fry left. The group was closely affiliated with both the Britons and the Nordic League, and in America with the German-American Bund.

All of the content is anti-Jewish, with much of it satirical, including all of the sections on the rear page: "Answers to Correspondents," book reviews of Lane's The Hidden Hand and Rev. Fahey's The Rulers of Russia, classified advertisements, and recommended literature. Also included is a cartoon by "Goy" (the pseudonym of Richard T. Cooper who would become President of the Britons in 1951) called "The Wandering Hebrew."

Three scarce issues of two newspapers issued by the Militant Christian Patriots (MCP), an anti-Semitic, London-based organization founded by Col. A. H. Lane in 1929 following the publication of his book The Alien Menace. The Free Press was founded in 1935 and edited by the enigmatic, peripatetic, rightist, Leslie Fry, who started a U.S. chapter in Glendale, CA, in 1936. She launched the Christian Free Press as that chapter's newspaper while editing duties for the Free Press shifted to J. F. Rushbrook, previous editor of the MCP's other short-lived newspaper, The Britisher (see item <u>20</u>). The organization and both newspapers were defunct by spring 1940.

The three issues included here are the *Christian Free Press*, nos. 19 & 27; Free Press,

no. 40. Issue 19 includes an article on the American Nationalist Confederation, the brainchild of Fry, but directed by George Deatherage; on organized Jewry as the "betrayers"; an article by Fry confederate Warren Weston (pseud. of Conrad Chapman, author of *Father of Lies*) on the continual immigration of Jews from Eastern Europe; three photographs of an anti-Jewish protest in Los Angeles; other anti-Jewish and anti-Negro content. No. 27 includes articles on the Temporary National Economic Committee (see item); on Palestine atrocities; excerpts from a speech by Gen. Van Horn Mosely; Communist propaganda at the World's Fair (with half-page illustration); other anti-Semitic, anti-liberal content. The issue of Free Press features an uncharacteristic article critical of Hitler for handing Poland to the Bolsheviks (the MCP was previously pro-Nazi) with an illustration titled "The Betrayal"; other anti-Zionist, anti-planned economy content.

All three tabloid format printed on newsprint. The two *Christian Free Press* issues are 8 p., the *Free Press* issue, 4 p., illus. Covers of no. 19 are nearly detached with chipping along the edges; no. 27 has tape securing covers, chipping along the edges; no. 40 is Near Fine. A broadside distributed by the American White Guard reprinting an article from the February 1936 issue of *The Catholic Gazette* titled, "The Jewish Peril and the Catholic Church," which includes extracts from a series of purported speeches made under the auspices of a Jewish Society in Paris. The Jewish speakers maintain that the Catholic Church is the primary institution impeding Jewish domination and discuss the many ways that they're undermining and subverting the credibility of the Church (which they've already successfully done to Protestants).


Numerous anti-Semitic organizations in Britain and the U.S. reprinted the article in a variety of formats, which are documented in Singerman. The American White Guard was a short-lived right wing group composed of disaffected members of William Dudley Pelley's Silver Shirt Legion. The group was allegedly organized in 1934 by "Captain" Eugene Case who headed the violent "actionist" cadre of the Legion, but also included Henry D. Allen, convicted forger and a ubiquitous presence amongst California proto-fascist and nationalist groups.

First published in a special issue of the *Revue International des Societes Secretes* (*International Review of Secret Societies*), this article traces the pontifical Bulls related to Jews and their "common character...of defending Christian communities from the penetration of the Jewish race and Talmudic ideas." Included is a table with the aforementioned Bulls from 1217-1755. This edition and its distribution appear to be the work of E. N. Sanctuary whose name and address are printed on the rear wrapper. Sanctuary was a ubiquitious presence in American far right circles and was rabidly anti-Communist and anti-Semitic.

An anti-Semitic sticker featuring the "Coat of Arms of the CIO," which depicts two Jews sitting back-to-back hiding bombs and cudgels under their winged cloaks. Listed are eight Jewish CIO leaders and an acronym for the USSR: Union of Soulless Swine and Robbers. Although no creator is listed, a letter from American White Guard founder, Henry Allen, to Jewish Community Committee operative, Charles Slocombe, who infiltrated the American White Guard, describes the stickers and implores "Charlie" to "put out as many thousand of the enclosed in Long Beach as you can possibly manage." He offers the stickers on gummed paper (our copy) for \$3.50 per thousand and on ordinary paper ("for hand distribution or mailing") for \$2.75 per thousand. 
25.) Ve Vant Var [We Want War] - Propaganda sticker. [Los Angeles?]: [German-American Bund?], [ca. 1941]. \$125

A small sticker featuring a Star of David with an accentuated 'V' and the slogan 'Ve Vant Var'. These stickers were distributed by Bundists, fascists and isolationists in opposition to the "V is for Victory" campaign, which they believed was a plot by the international bankers (Jews) to capitalize on another world war. One group who distributed the stickers was the Friends of Progress, a Los Angeles-based anti-Semitic organization founded by Robert Noble and Ellis Jones. In a 1945 court case against members of the group for for violating the Subversive Organization Registration Act, witnesses stated that the stickers were sold by the bundle at Friends of Progress meetings, that member James McBride had distributed them, and that the sticker had been seen on the desk of West Coast Bund leader, Hermann Schwinn.

In the Nov., 1941 issue of *The Beacon Light*, American fascist, William Kullgren, published a long article on the V campaign and explained it thusly: "This 'V' symbol stands for getting America into war, and all that implies: staggering taxes, strikes, suppression of free speech, free press and civil liberties, along with panics, depression, investment losses, bank failures, etc., all punitive measures to either bring on war or revolution or both. When the storm breaks, somebody will wish they lived in Madagascar." This latter threat was in reference to the early Nazi plan to forcibly relocate the European Jewish population to the island of Madagascar. Kullgren mentions the 'Ve Vant Var' slogan in his article.

Carter; "Jewish Press Control Bars Truth Being Told" by James True ("Industrial Control Report"); "The Communist Negro Menace" by Robert Edward Edmondson ("Edmondson Economic Service"); "The Jews Behind the Red Revolution" by Albert Starr, Jr.: "The Truth About 'Teachers' Oaths'" by James Carlson; "Good Neighbor League Unmasked" by John Elbert Hatfield; "Government Communizes Indians Against Their Will" by Clare B. Smythe; photographs of Jews in the Roosevelt administration, "An actual photograph of a Jew Commissar dinner party in Moscow, taken while millions of Christians were starving throughout that nation," and a centerfold spread of doctored photographs showing "The Roosevelt-Frankfurter-Farley Social-Equality-Loving Administration Prefers Negroes and Jews."

A pamphlet accusing Congressman Martin Dies and his Dies Committee of betraying American patriots by smearing them as Nazis and Fascists at the behest of his Jewish handlers. He labels the Committee "a Jewish OGPU" and rebukes it for suppressing the anti-Semitic statement of Major General George Van Horn Moseley.

Deatherage, who at this time was operating the Knights of the White Camellia, was investigated by the Dies Committee and was later one of the defendants in the Great Sedition Trial. In 1937, with the backing of Leslie Fry, he established the American Nationalist Confederation to unite many of the disparate groups on the extreme right. He used the swastika as the group's symbol.


Originally published in French in 1937, La clef du mystère [The Key to the Mystery] was an anonymously compiled tabloid of anti-Semitic material based on the Protocols of the Elders of Zion. It was published under the auspices of the Ligue Féminine Anticommuniste de Montréal [Montreal Women's Anti-Communist League], a front group of the Parti National Social Chrétien de Canada (PSNC), the fascist party founded by Adrien Arcand and Joseph Ménard. Authorship has been erroneously ascribed to both Gabriel Lambert and Paul Émil Lalanne, but according to Arcand's biographer Jean-François Nadeau, Arcand acknowledged authorship (Nordeau, p. 197). It was described by one scholar as "undoubtedly the most vicious defamation of the Jewish people ever published in Canada" (Betcherman, p. 91).

The tabloid was distributed in France by the *Centre de Documentation et de Propagande*, run by Henri-Robert Petit and Henry Coston - and frequented by Céline, in Switzerland (by Princess Karadja), and in Belgium and Germany. It was translated into English and sent to the U.S., although at least one shipment was seized by American authorities due to the efforts of the Canadian Jewish Congress (Nordeau, p. 200). This "exact reprint" was undertaken by the Chicago-based *Women's Voice*, the anti-Semitic newspaper of Lyrl Clark van Hyning's We the Mothers Mobilize for America, and was published sometime in the late 1940s/early 1950s.

28.) Who Wants War? And Why? Will We Have War? Why Our Unemployment and Distress? Hear Russell Dunn, Wed. April 19, 1939 | Christian-Americans Unite | Destroy Communism | American-Nationalist Party. New York: American Nationalist Party, 1939. \$425



A scarce flyer for a meeting of the American Nationalist Party, which features a crudely drawn illustration of a Jewish (?) "communistic war creator" prodding the "dogs of war" while an approving FDR provides encouragement. "Who Wants War? And Why" was a popular slogan used by isolationist and anti-Semitic groups as a means to indict the war-mongering Jews for pushing America toward war on behalf of their interests.

The American Nationalist Party was an isolationist, anti-Semitic, and self-avowed fascist group founded by Stanley Alexander Smith of New Jersey to a number of New York anti-Jewish men in November, 1937 (see p. 107 of Edmondson's *I Testify* (item <u>80</u>) for a brief history of the group). The group held meetings around New York City in which speakers such as Smith, Henry George Curtiss (pseud. of John Gaede), Robert Edward Edmondson, Eugene Daniels, John Cecil, William Meyer, Charles Hudson and Joe "McNazi" McWilliams harangued the crowd with anti-Semitic vitriol (see Carlson's firsthand, sensationalized account on pgs. 38-43 of *Under Cover*). According to Carlson, the group was a "training school for a score of potential anti-American leaders." They also operated a "storm trooper's unit which trained regularly in a Yorkville gymnasium..., [and whose curriculum] consisted of military drills, jiujitsu, rioting tactics... [and] the manual use of arms and the use of clubs, blackjacks, brass knuckles and alley-fighting (pgs. 42-43). Members were also affiliated with the German American Bund and the Christian Front. The group appears to have dissolved in 1939.

They are not to be confused with the west coast American Nationalist Party founded by Ingram Hughes in 1935 and affiliated with both the Klan and the proto-Bund group Friends of New Germany; nor is it to be confused with ex-Senator Robert Rice Reynolds' post-war far right group, also called the American Nationalist Party.

WHO MADE THE LAST WAR?

On February 17th, 1921, the New York World published a lengthy interview with Mr. Henry Ford in which he made some very clear and definite remarks about the authors of the Great War and all its miseries. Here are some passages:-

INTERVIEWER: "How long have you had the idea that there was anything about the so-called international Jewish system which should be placed before the American public?"

Ms. Fosc: "I have been thinking about this matter for many years, but not until about five years ago, on the Peace Ship, did the full importance of the subject come into view. That voyage gave me an insight into the responsibility for the war and who profited by it. It is surprising how frequently you come upon the same groups of

"You know back in 1915 I said I was going to devote my life and fortune to bring about an end to war. That was not just talk, I meant it then, and I mean it more than ever now. In studying the possibilities of paramount World Peace from every angle, I studied the causes of war, and I am convinced that nearly all wars were caused so that someone would profit, and those who have profited and when the string now was the integrational financies; the Jawa who are profiting now are the international financiers, the Jews, with possibly a few Gentiles with Jewish connections. They are what is called the 'International Jews,'—German Jews, French Jews, English Jews and American Jews.'

INTERVIEWER: "Is your belief that the Jews are endeavouring to control the world based in any degree on the so-called PROTOCOS... said to have been formulated by the Elders of Zion? You know, of course, that these have been denounced as forgeries or inventions. Do you believe they are genuine?

MR. Form: "The only statement I care to make about the Prorocous is that they fit in with what is going on. They are sixteen years old and they have fitted the world situation up to this time."

The Jewish World of January 5th, 1922, quotes from an interview the following statement by Mr. Ford which amplifies part of the above and fixes on Jews themselves the confession that they were solely responsible for the Great War. Said Mr. Ford:-

"It was the Jews themselves who convinced me of the direct relations between the International Jew and the war; in fact, they went out of their way to convince me.

You remember the effort we made to attract the attention of the You remember the effort we made to attract the attention of the world to the purpose of ending the war through the medium of the so-called Peace Ship in 1915. On that ship were two very prominent Jews. We had not been to see 200 miles before these two Jews began tellin, me about the power of the Jewish race, how they controlled the world through their control of gold, and that the Jew and no one but the Jew could stop the war.

"I was reluctant to elieve this, and said so. So they went into details to tell me the means by which the Jews controlled the war—how they had the money, how they had cornered all the basic materials needed to fight the war, and all that, and they talked so long and so well that they convinced me. They said, and they believed that the Jews had started the war, that they would continue it as long as the said of the said of

This bears out the claim of the Jewish World of August 10th, 1921, that the Balfour-Rothschild declaration "has done its work in contributing, as it undoubtedly did, towards the winning of the war for England."

Speaking at a Jewish Conference in New York, Lord Melchett (Sir Alfred Mond), referring to the Jewish National Home (Palestine) movement, said :-

29.) Who Wants War? And Why? Mount Vernon, Washington: The Concord Press, [ca. 1939]. \$250

A small two-sided poster that warns of the Jewish attempt to instigate another world war for the benefit of International Jewry. The recto features excerpts from a 1921 interview with Henry Ford who discusses Jewish involvement in WWI as fulfillment of the Protocols. This is followed by excerpts from Zionists in Jewish publications to support the aforementioned conclusion. The recto then includes a quote from Bernard M. Baruch on destroying Germany's barter system followed by an editorial comment: "Here emerges the typical huckstering Jew avidly envisioning an opportunity for transforming Christian blood into gold..." Also included are other Ford quotations from 1938-39 and a facsimile reproduction of a handbill circulated in Britain that contends that the British Army is led, fed and clad by Jews.

Although we were unable to determine the creator of this poster, one possibility is Judge N. W. Rogers, whose pamphlet, Swindle: The Federal Reserve "Our Misfortune" was also printed by Concord Press the previous year. The flyer's admonition to "Read 'The Protocols of the Elders of Zion' was included on other Rogers propaganda and he was very active as an anti-Semitic propagandist during this time (although far from the only one). Not much is known about The Concord Press or who operated it, but like Pete Stahenberg's National Press Association, it was an active interwar printer of anti-Semitic propaganda.



30.) Why Are Jews Persecuted for Their Religion: The Truth is Stranger than Fiction! Bremerton, Washington: American Publishing Society, [1938]. SOLD

"In the fall of 1938 while riding in a New York subway, I picked up a leaflet entitled "Why Are Jews Persecuted for Their Religion?" It was printed on cheap, grey newsprint and included four pages of bitterly anti-Semitic quotations and distorted passages from American history. The leaflet urged 'American patriots' to 'rise up as one man and clean house politically and economically'. It bore the imprint of the Nationalist Press Association, 147 East 116th Street, New York. Pricked by curiosity I decided to look up these headquarters of 'Americanism'." And thus begins John Roy Carlson's sensationalized exposé of American fascism, Under Cover: My Four Years in the Nazi Underworld of America (1943).

As Carlson later documents, the leaflet originated in Bremerton, WA, courtesy of an obscure publisher called the American Publishing Society (see also item 8), a clearinghouse for anti-Semitic propaganda such as the *Protocols*. The publisher operated anonymously (i.e., no individual was listed as a contact), but Joseph P. Spencer admitted his affiliation to Carlson and may have been its sole employee. His authorship of this leaflet remains unverified. The text is essentially a compilation of anti-Semitic material and includes the "The Code of the Jew" from the Talmud, the spurious Benjamin Franklin quotation concerning the Jews, and excerpts and quotations from other Jewish and anti-Semitic sources. The leaflet was quickly reprinted by Pete Stahrenberg's Nationalist Press Association and decades later by the anti-Semitic propagandist Joseph Dilys. This copy includes the printed admonition to read John 7:13 and 8:44; Rev. 2:9, which does not appear on other American Publishing Society copies we've handled, nor on any other edition. A quintessential anti-Semitic item distributed among the growing fringe of American nationalists and conspiratorial patriots during the 1930s.

31.) Edmondson, Robert Edward. Court Dismissal Follows Jewish Backdown. New York: Published by the author, 1938. SOLD

One of many bulletins issued by the anti-Semitic propagandist Robert Edward Edmondson, this one celebrating the dismissal of a lawsuit brought against him Mayor Fiorello La Guardia and the People of the State of New York for libel against the Jewish people. The American Jewish Congress, American Jewish Committee, American Committee on Religious Rights and Minorities, and the ACLU urged a dismissal of the case lest it set a dangerous free speech precedent. Edmondson concurs by stating, "It is a World Victory by National Patriotism and Freedom of Speech over International Jewish Communistic Socialism" (p. 1).

Robert Edward Edmondson (1872-1959) was a journalist, editor, financial writer, and investment analyst who established the Edmondson Economic Service in 1934 to focus on publicizing Jewish financial and political subversion through a weekly bulletin. He claimed to have distributed five million copies of his bulletin in only two years of operation. In 1939 he moved his operation to Stoddartsville, Pennsylvania, then Scranton before moving to the west coast. He died in Bend, Oregon in 1959. He was a defendant in the Great Sedition Trial of 1944.



33.) Lest They Forget! American Has Her Own Refugees. New York: Christian Front, [1938]. SOLD

A circular issued by the Christian Front in opposition to the proposed Asylum Bills, which they contend would flood the U.S. with alien labor during a time of high unemployment. As an illustration, they describe "the alien infiltration of the American music field," in which a group of Austrian political and religious refugees, Hans Eisler, Arnold Schoeneberg [sic], Ernst Toch, Hugo Leichtentritt, and Felix Gratz (mostly Jews), displaced American musicians. Also included with the circular is a small Christian Front pinback button.

The Christian Front was founded in NYC in early 1939 as a militant Catholic group against Communism (and specifically Jewish-Communism), and was based on an idea concocted by the British Catholic convert Arnold Lunn during the Spanish Civil War. Incorporating Mystical Body theology and Social Action, it was conceptualized as Catholicism's best defense against World Communism. Father Charles Coughlin popularized Lunn's idea and provided the blessing for its official founding around February 1939. The group was soon led by its Brooklyn unit commander, Daniel Cassidy, who'd previously run the Christian-American Committee Against Communism (CACAC), a militant anti-Communist, anti-Semitic group. Besides hosting raucous rallies and meetings described by Arthur Derounian in his expose *Under Cover*, the group began firearms training and experimenting with bomb making. They were soon surveilled by the FBI who arrested 16 members in January 1940 on weapons and conspiracy charges. The government embarrassingly lost the case and the group continued to grow, especially in Boston where it was led by Francis Moran who collaborated with Nazi spies during WWII. The group officially disbanded in 1942, although members went on to join other far right, anti-Semitic groups. Charles R. Gallagher's recent book on the Front's origin and activities is the single best source (Nazis of Copley Square: The Forgotten History of the Christian Front, Harvard Univ. Press, 2021).

34.) Castorina, Paul (editor). Blackshirt, Vol. 1, No. 5. New York: Blackshirt Publishers, 1939. \$350

The fifth and final issue of *The Blackshirt*, the organ of the short-lived American Fascist Party founded in NYC in 1939 by Francesco Paulo Castorina (aka, Paul Castorina). The paper was billed as a "monthly Journal of Aggressive Patriotism" and featured a disclaimer at the top of each issue: "This Paper has no connection whatsoever with any Italian Organization." But Castorina clearly modeled both his organization and its paper on Italian fascism, while adopting both the emblem and the paper name of the British Union of Fascists. In NYC, the American Fascist Party was closely affiliated with the German-American Bund and the Christian Front (Castorina held membership in both organizations), and Carlson mentions seeing "The Blackshirt" at a meeting of the anti-Semitic American Nationalist Party.

All of the content for this issue is unsigned and was presumably written by Castorina, which includes short articles on Jewish Communism, the Jew monopoly in Hollywood, the Jewish corruption of the medical industry, and the activities of the American Fascist Party. Not to be confused by an earlier paper named the "Black Shirt," the organ of the American Fascisti published in Atlanta, GA.

35.) Cherep-Spiridovich, V. [A scarce group of anti-Semitic publications from Count V. Cherep-Spiridovich.] New York: Published by the author, 1938-39. SOLD

A group of publications from the eccentric anti-Semite V. Cherep-Spiridovich, one of the many aliases of Howard Victor Broenstrupp (1886-1963), an Ohio-born lawyer who became a key figure in the extreme right fringe during the 1930s and 1940s. Broenstrupp claimed to be the adopted son of Maj.-Gen. Arthur Cherep-Spiridovich, an anti-Semitic White Russian best known for his work, The Secret World Government, or "The Hidden Hand," but there was no evidence for such a claim.

Having been disbarred in 1913, Broenstrupp worked for the WPA during the 1930s as a research editor for the Aeronautics Index project before dedicating himself full-time to the cause of anti-Semitism. He abandoned his second wife to work with William Dudley Pelley, an episode told by journalist John Roy Carlson (Arthur Derounian) in his book *Under Cover*. Derounian describes Broenstrupp as "an emaciated, coarse-featured man, toward whom I experienced an instant dislike" who was living in the "squalor of a grimy tenement in the heart of New York's slum district" (p. 341). In 1942 he went on the run to avoid sedition charges, but was arrested along with Pelley's daughter and five other supporters who were charged with harboring a fugitive. He was thereafter freed when the government's Great Sedition trial imploded in 1944.

Included in this grouping are three successive issues of the small format "Intelligence" newsletter, which Broenstrupp claims to be the successor to Count Cherep-Spiridovich's Gentiles Review; three issues of his American Tribunal newsletter (also described as Intelligence Bulletins); and a copy of a 1939 letter sent to Congressman Martin Dies. In one issue of the American Tribunal, he extols the Ku Klux Klan: "The NEGRO-ASIATIC JEW hybrid was a difficult problem for the KU KLUX KLAN, but the "WHITES" won. The rising tide of color, stimulated by the JEW, was stemmed. It was an experiment in DE-MOcracy, which furnished an example for our present times." Another issue features his most "famous" essay, "Revolution in America," and also includes a short article by the Squire of Krum Elbow (the pseudonym of fellow eccentric, anti-Semite and millionaire, Howland Spencer). In his letter to Congressman Dies he congratulates him for inadvertently "further STIMULAT[ING] the rising tide of AMERICANISM which in turn SPURS up ANTI-JEWISM, leading eventually to the return of CHRISTIAN DOMINATION of our GOVERNMENTAL ADMINISTRATIONS with each NATIVE AMERICAN proud of his or her own ORIGIN." A bizarre, entertaining, and incredibly scarce grouping. Seven items total.

A circular issued by E. N. Sanctuary, which describes the methods by which Jewish Communists - under the guise of the New Deal - will use to orchestrate a collapse of American capitalism in order to establish a world Jewish state. A list of prominent Jews involved in the New Deal are listed at the bottom. The verso includes an essay elaborating further on the same conspiracy.


Col. Eugene N. Sanctuary was a civil engineer who during WWI claimed to have seen the documents by which the Jewish banker, Jacob Schiff, transferred \$1,000,000 to Lenin and Trotsky for the Russian Revolution (Strong, p. 129). He headed the American Christian Defenders and the World Alliance Against Jewish Aggressiveness, both one-man organizations that distributed Sanctuary's pamphlets and those from other far right organizations. He was a defendant in the Great Sedition Trial.



37.) [A typed letter from the anti-Semitic Federated Christian Patriotic Societies to members of the Temporary National Economic Committee]. New York: Federated Christian Patriotic Societies, 1939. SOLD

A scarce letter from the Federated Christian Patriotic Society to the members of the Temporary National Economic Committee protesting that organization's composition, aims and activities. It states: "Our delegation has come to Washington to serve individual and collective notice upon the members of the TEMPORARY NATIONAL ECONOMIC COMMITTEE that they do not propose to allow said committee to continue under the cover of "MONOPOLY INVESTIGATION" schemes which spell the control of private investments or confiscation of property, or the despoiling of the Christian population by Zionist or any other section of organized international Jewry." The letter is signed in type by the American Nationalist Party (see item <u>28</u>), American League of Christian Women, Militant Christian Patriots (see items <u>20</u> & <u>21</u>), and the Christian Front (see item <u>33</u>), all associated with the anti-Semitic fringe. Surprisingly, the group does not appear in Carlson's *Under Cover* (1943).

38.) [Tietzow, Olov E.]. Two anti-Semitic flyers from the American Guard. Boston: The American Guard, [ca. 1940]. SOLD

The American Guard, which billed itself as "The White Man's Party," was a pro-white, anti-Semitic organization founded in Chicago in 1936 by the Swedish-born Olov Tietzow. In *Under Cover*, John Roy Carlson calls Tietzow "American Nazidom's traveling emissary" and quotes him uttering sentiments such as: "I have no faith in constitutional methods...Nothing will work here but a military coup d'etat." Tietzow was the author of the book *Aryan Americanism* (1937).

In "Failure of the Ballot," Tietzow dismisses voting as a means to affect change as evidenced by the return to power of the "international, pro-Jewish, and pro-British New Deal" in the 1940 election. The flyer concludes with the declaration: "Youths of America! Your elders have failed to properly safeguard our country's interest. Upon you, therefore, rests the burden of freeing the nation from internationalists, war mongers, and corrupt politicians. Do you have the courage to fight the battle? If so, make ready - for the sake of home, country and race!"

In "Congress - Watch Your Step!," Tietzow accuses the Jewish, Masonic internationalists of employing warmongering tactics to lead the U.S. into a war that will benefit world Jewry. Tietzow warns, "At the end of the war, or even before it is over, our people can turn the guns against those responsible for our entry and bring a merciful end all who, in and out of Congress, betrayed the nation in the name of Judah."



A rambling treatise on the planned depressions orchestrated by the International Bankers and the complicity of the Federal Reserve. Brumback followed this book with *A Manual of The Citizens No Foreign War Coalition, Inc.* (1941), the assertions of which were so outlandish that even Elizabeth Dilling, the den mother of anti-Semitic conspiracy theories, asked him for documentation to which he replied, "I have it all at home" Carlson, 216). A second edition was published in 1937. Brumback was indicted for sedition during WWII but did not stand trial.

The book includes 17 short vignettes for children written by Der Stürmer editor Ernst Hiemer, in which Jews are portrayed as lecherous, corrupting, unhygienic, dishonest, avaricious, parasitic, etc. The stories are illustrated by 'Fips', the pen name of cartoonist Phillip Rupprecht, who con-

tributed nearly all of the cartoons to *Der Stürmer*. The book was the first of a number of children's titles published by Streicher and was used in some German classrooms as a teaching tool against Jews.

A notorious Nazi Party photo-document portraying prominent Jews in the United States as gluttonous, degenerate, criminal, exploitative and politically influential. The unflattering cover photo depicts anti-fascist NYC mayor, Fiorello La Guardia, gorging on a plate of food (La Guardia's brother-in-law was later killed in a concentration camp). Other photos show influential Jews in Roosevelt's administration, Zionists, Jews living in squalor on the Lower East Side, Jewish gangsters, Hollywood producers and actors, financiers, cultural producers, etc. All with long, hyperbolic captions describing the Jews shown. The final photograph shows a homeless American sleeping on the sheet with a caption that opines that in a USA-Soviet paradise that only the Jew will live well.

An uncomfortable but necessary coupling of Theodore Kaufman's Germany Must Perish with the Nazi Party's Das Kriegsziel der Weltplutokratie. In 1941, Kaufman, an unknown Jewish owner of a theatrical ticket agency in Newark, NJ, published Germany Must Perish, an unhinged proposal on the necessity of eradicating Germany through the forced sterilization of its people and the disbursement of its lands. Kaufman first broached the topic of sterilization in 1939 while leading a one-man organization called the American Federation of Peace, in which he proposed sterilizing Americans if the U.S. became embroiled in a European war. Not finding a publisher for his radical treatise, he founded Argyle Press, and as part of his marketing campaign sent reviewers small hand-made coffins containing a card that read, "Read GERMANY MUST PERISH! Tomorrow you will receive your copy." Kaufman aggressively self-promoted the book leading to reviews in the New York Times, Washington Post, TIME Magazine, and the Philadelphia Record. A TIME reviewer compared it to Jonathan Swift's A Modest Proposal - without the irony (see, "Modest Proposal, TIME Magazine, Vol. 37, No. 12, March 24, 1941). His creative interpretation of the


dismissive reviews landed as promotional blurbs on the rear cover of this second printing, and more importantly caught the attention of Joseph Goebbels and the Nazi Party.

Writing in his diary, Nazi Minister of Propaganda, Joseph Goebbels, wrote: "This Jew [Kaufman] did a real service for the enemy [German] side. Had he written this book for us, he could not have made it any better. I will have this published in an edition of millions for Germany and above all for the front, and will write the forward and afterward myself" (qtd. in Bytwerk). In September 1941, the NSDAP publishing house issued five million copies of Das Kriegsziel der Weltplutokratie. The pamphlet included many excerpts from Germany Must Perish with outlandish claims that Kaufman was a member of Roosevelt's "Brain Trust" who facilitated a meeting between the President and Churchill. This was followed a month later with a four page pamphlet titled, When You See This Symbol... justifying the Nazi use of the Yellow Star on Jews to protect Germans from Kaufman's diabolical plan. The pamphlet was sent to every German along with their ration card. By 1944, Kaufman's book was still being used in German propaganda to remind the German people what the Nazis were fighting against. (continued on next page)

Kaufman followed up *Germany Must Perish* with a less radical proposal in *No More German Wars: Being an Outline of Suggestions for Their Permanent Cessation* (1942) and then quietly disappeared from the historical record. His book and legacy have been kept alive by a string of far right publishers who have kept *Germany Must Perish* in print to justify Germany's wartime treatment of the Jews. Both titles are uncommon in the trade, moreso paired together.

43.) Der Untermensch. Berlin: Nordland Verlag, [1942]. \$950

A vicious piece of Nazi propaganda, in which German Aryans are contrasted with the "untermensch," or "sub-human," a category encompassing Jews, Slavs, the feeble-minded, etc. Photographs portray Germans as clean, healthy, industrious and the creators of high culture whereas Jews and others from Eastern Europe are depicted as dysgenic, dirty, bestial, lazy, and living in squalor. Other photographs depict noble German art and architecture juxtaposed with the degenerate art of the Jew. The final six pages of photographs show mutilated and murdered Germans and warn of the need to defend Europe from the hordes of untermenschen. The book was published by SS publishing house Nordland and widely distributed in Germany. It was translated into Greek, French, Dutch, Danish, Bulgarian, Hungarian, Czech and seven other languages.

The term "untermenschen" was purportedly coined by the American racial theorist Lothrop Stoddard from his book *The Revolt Against Civilization: The Menace of the Under-man* (1922). It was adopted by the Germans following the German translation of Stoddard's book.

44.) Leers, Prof. Johann von (prepared by). Die Juden in der Welt (Lehrschau-Bogen, no. 26). Berlin: Reichswaltung des Nationalsozialistischen Lehrerbundes, [ca. 1941]. \$500

A two-sided teaching poster issued by the National Socialist Teachers Association, which published the monthly magazine *Hilf Mit!* under the editorship of Heinz Görz. The poster illustrates the universal Jewish role as political agitator, warmonger, ritual murderer, etc. through photographs, watercolor illustrations and a map The map shows the Jewish population around the world to demonstrate its small proportion, but outsized role and influence in world affairs. Also included are photographs of British politicians Winston Churchill and Duff Cooper and the British Jew Leslie Bore-Helisha, as well as Jewish French Prime Minister Leon Blum and the French Jewish journalist Georges Mandel. The accompanying text was written by Prof. Dr. Johan von Leers, a high-ranking SS members and anti-Jewish ideologue who later converted to Islam.

The Dutch edition of Dr. Peter Aldag's *Juden beherrschen England* [*Jews Rule England*] (1939), an anti-Semitic work investigating the role of British Jewry in English society during the 19th and 20th centuries. Two years later Aldag published Juden erobern England [Jews Conquer England] and in 1943 the two books were published as Das Judentum in England [Judaism In England], a nearly 600-page, extensively footnoted, two volume set that one Jewish reviewer called a "farrago of Nazi lies" (Kirshner).

Dr. Peter Aldag was the pseudonym of Fritz Paul Heinrich Krüger, a German lawyer and SS member who arrived in Britain in 1935, officially to study British law, but unofficially "...to study the Jewish question" and to "engage in anti-Jewish propaganda in English circles" (Holmes, p. 262). Krüger's activities aroused suspicion and he was banned from England in 1939. He was imprisoned from 1945-47, but later resumed a successful law practice and became an arms exporter to the Arab world in his continued fight against Judah.




46.) Wirsing, Giselher. The 100 Families That Rule the Empire. Scotch Plains, New Jersey: Flanders Hall, 1941. \$85

A pro-German work critical of the British oligarchy. Wirsing's work was originally published in Germany - in both German and English editions - in 1940 and reprinted a year later by George Sylvester Viereck's Nazi propaganda imprint, Flanders Hall, which was based in NJ. The author based much of his analysis on Simon Haxey's 1939 book, *England's Money Lords*, and includes Haxey's detailed charts of the British aristocracy, politicians, and financial figures, including a fold-out one of "The 'Cousinhood' in the House of Commons." The book's anti-Semitism is more subtle, with veiled references to "alien elements" influencing the oligarchy. Wirsing was a member of the Nazi Party and authored many books of German propaganda before and during the war.

47.) Hutten, Dietrich. Defilement of Race (Rassenschändung). [Los Angeles?]: [Harry Warner?], [1939]. First English language edition. \$250



An English language translation and facsimile reproduction of the widely circulated German pamphlet *Rassenschändung* (1937) by the German race theorist Dietrich Hutten, in which he describes the irreconcilability of German racial purity and Judeo-Christianity. As stated by Hutten at the beginning, "In order to make the German finally realize the importance and value of his race, this little pamphlet will prove - in broad outline - how Judaism, with the aid of Christianity, has served to defile and to destroy the race" (p. 3).

Although no editor or publisher is listed, this reprint was apparently undertaken by Jewish studio boss Harry Warner in 1939 and distributed to Warner employees. A notation inside the rear cover reads, "Recd from Harry M. Warner / Warner Bros. Studios / Burbank, Calif. / March, April, 1939. Originally distributed to his employees." This is verified in a short article titled "Hollywood Expose" in the March 17, 1939 issue of *The Jewish News of Northern California*, in which Bud Freed writes that "This week every worker on the Warner lot will receive along with his pay check a copy of the German pamphlet, '*Defilement of a Race*' [sic]." Freed goes on to write that Warner was responsible for the foreword, an unsigned blurb on the front wrapper that states:

"This is a translation and also an actual reproduction of a German work so widely distributed within the Reich as to be almost a text book to those who follow the appalling philosophy of Naziism. It was translated because an

American reader felt its contents were of extreme importance as a warning to those who do not fully realize the menace that confronts us all. Here in this little volume is the whole sordid and almost incredible proof of the danger that threatens not only the decencies but the very existence of civilization."

The cover illustration from the original edition is reprinted inside the front wrapper. The text alternates between the original German and the English translation. Hutten, relying heavily on the work of German race theorist Hans F. K. Guenther and the conspiratorial esotericist Dr. Mathilde Ludendorff, concentrates on the centrality and veneration of Germanic women as "guardian of the folk-soul," and the contrasting defilement of women under Jewish-Christianity.



49.) Taylor, Lt. Col. Waters. Eighth Crusade: Uncensored Disclosures of a British Staff Officer. Hollywood, California: Sons of Liberty, [197-]. Reprint. \$45

Originally published in 1939 as Nazi propaganda to "prove that the Palestine 'impasse' is typical of what Jewry is doing to disrupt the world," the book was authored anonymously by a British military officer who describes his forced anonymity in the preface: "The paramount ascendancy of the Jew in England today renders the publication of the author's identity undesirable until such a time as Englishmen are free to express an opinion on the Jewish menace to their own country without being flung into prison" (pgs. vi-vii). In this later edition published by James K. Warner's Sons of Liberty, the author is listed as Lt. Col. Waters Taylor (Colonel Bertie Harry Waters-Taylor), who served as Military Governor of Jerusalem and Galilee. He was alleged to have allowed the 1920 Nebi Musa riots to occur to show that the Palestinians would not tolerate Zionist expansion.

The book is divided into three parts: the history, origin, and growth of Zionism; European politics in the context of Zionism, including the Anglo-Shereefian machinations, the Sykes-Picot Treaty and the Balfour Declaration; and the author's personal experiences in Syria and Egypt during and after WWII and at the Peace Conference in Paris.



This Hollywood "Imbroglio of Immigrants" is a nepotistic monopoly that blacklists any director, producer or actor who challenges its hegemony and who uses its propagandistic films to spread hatred. Phelps followed up this work with *Hollywood: The Fifth Column of America*, and a pamphlet suggesting that Jews be shipped to Birobidjan.


George Allison Phelps (1893-1953) was a poet, radio broadcaster and journalist who increasingly turned his pen and voice to the cause of anti-Semitism. He was an associate of Gerald L. K. Smith and was a fellow right wing demagogue in Los Angeles. Following WWII, Phelps set up an anti-Semitic organization called the US Americans, but it dissolved in 1947. He was featured prominently in Lowenthal and Gutermann's *Prophets of Deceit: A Study of the Techniques of the American Agitator* (1949).



He self-published a number of anti-Semitic booklets and wrote for other anti-Semitic organizations such as those led by Father Coughlin and Gerald Winrod.



Arthur Terminiello (the "Father Coughlin of the South") at the Novena in honor of Our Lady of Victory at the Church of the Visitation, Huntsville, Alabama, and broadcast over the North Alabama Network on Oct. 22, 1944. Terminiello insinuates that Pearl Harbor was engineered as a pretext for forcing America into war by "rabble-rousers of our nation…who see only the picture of the assembly line, the counting houses, the magnificent offices and the profits" (i.e., the Jews). Terminiello's sermon was delivered during the Great Sedition Trial of 1944 and he condemns the persecution of the "26 old men and women" being held "without a shred of evidence" (p. [8]).



A lengthy booklet from the Salt Lake City attorney and nationalist Jeremiah Stokes, which he describes as a "compilation of documented knowledge which contrasts America's Fundamental Law with the Communists' Fundamental Law and shows the Communists' threat against this Nation and the people's freedom. It contains both a warning and a remedy." Section 31 (The Jewish Question) criticizes "Criminally minded apostate Bolshevik Jews" for "agitating the issue of anti-Semitism" as a cover for their subversion. In Section 32 (The Criminal and Apostate Jews Against Whom A War Of Exposure Must Be Wages), Stokes documents the anti-Christian animus of Jew-Communists. Part of the booklet responds to Arthur Derounian's smear of Stokes in *Under Cover*.



Kister blamed the Jews for Communism and campaigned on behalf of veterans who he maintained were forced to compete with alien labor for scarce jobs. The group established chapters in a number of cities and featured prominently in Arthur Derounian's post-war expose, *The Plotters* (1946).



A single issue of the anti-Semitic, nationalist newsletter of Frederick Kister's Christian Veterans of America. This issue includes an anti-FDR editorial by Kister; the results of a libel trial in which "The Sentinel," a Chicago Jewish publication, and its two publishers, J. I. Fishbein and J. M. Feldman were found guilty of libeling four defendants in the Great Sedition Trial; a parable featuring an ant named John Roy Charleston (undercover journalist John Roy Carlson [Arthur Derounian] who wrote extensively and critically on Kister in his book *The Plotters* (1946)), a book review of George Creel's *Rebel at Large*, and a closing note from Kister.

An isolationist, post-war work written by an Army veteran highly critical of the "Arch-Traitor of the Twentieth Century," Franklin D. Roosevelt (see chapter IX, "Traitor in the White House"), and surprisingly sympathetic to Hitler and Germany throughout. Although Xavier barely mentions the Jews, he calls out the "Internationalists" and "Interventionist war mongers," and dismisses anti-Semitism as a "regrettable disease, which accompanies harsh economic circumstances" (p. 173).


Xavier would later drift further toward the far right as editor of the anti-Semitic *Dayton Independent*, member of the National Security League (described by the FBI as an "anti-Jewish, anti-Labor, anti-Negro front organization") and as a founding member of the National States Rights Party, for which he was treasurer (Newton, p. 46). Xavier was involved in a deadly shooting at an NSRP event in Berea, Kentucky in 1968, in which an NSRP member and a black woman were killed (Newton, p. 168).



An eccentric work, in which the author alleges that a secretive group of International Financiers operating out of London and connected with the Bank of England, direct American foreign affairs. He discusses geopolitics and outlines the five ideologies of space and power: "One World" Ideology, "Pan-Slavic" Ideology, "Asia for the Asiatics," Pan-Germanism and Pan-American Isolationism. There are separate chapters on the House of Rothschild and House of Sassoon. First self-published by the author in 1944, this second edition adds Chapters I and XI, and a Conclusion. The book was later republished by a variety of far right publishers under a number of similar titles.

A pamphlet from the tireless right wing propagandist, Marilyn Allen, on the difference between Jewish-directed Communism and Christian Americanism. Allen documents the many forms of Jewish control and influence within various U.S. spheres and government agencies. She also refutes claims about her made by John Roy Carlson (pen name of Arthur Derounian) in his book *The Plotters* (1946), suggests that Negro Communists be deported to Liberia, and contributes numerous poems expressing her love for America and Salt Lake City.

Marilyn Ross Allen (1890-1977) was born in Ohio and lived there until at least 1935. She appears in the 1940 census living in Atlanta with her widowed mother and working as a private secretary for a publishing company. (This compared with Ralph Lord Roy's profile which states that she was Southern-born and working as a secretary to a Jewish insurance agent.) According to Roy, she fled to Salt Lake City for fear of race riots where she spent the next three decades churning out anti-Semitic, anti-Communist, and white supremacist propaganda (p. 108). In 1949 she published her magnum opus, *Alien Minorities and Mongrelization* (1949), a nearly 500-page screed against communists, blacks and Jews and a "clarion call, a CHALLENGE to WHITE CHRISTIAN AMERICANS to protect, defend, and preserve their racial heritage, their fast-dwindling freedom, and their CONSTITUTIONAL rights." Despite her extremist views, Allen complained bitterly about having to self-finance her publications (Carlson, *Under Cover*, p. 152). She died in 1977.





A small format circular by the anti-Semitic propagandist Einar Åberg of Sweden. Åberg quotes from a variety of Jewish sources concerning the designs of world Jewry and then cites John 8:44 as proof that the Jews are the children of Satan.

Åberg (1890-1970) founded the Anti-Jewish Action League of Sweden and was the country's most active anti-Semitic propagandist, often corresponding with leading anti-Semites around the world. He was jailed numerous times for his activities and was one of the first Holocaust deniers following the end of WWII.

He also ordered the prohibition of usury, removed protection for them on the highways, confiscated their religious books, forbade their rabbis from preaching, etc.



63.) Christian Rejoicing - - Judaistic Sorrow and Plotting [with] "The Code of the Jews" From the Talmudic Writing [Easter Evening 1949]. n.p.: n.p., [1949?]. \$150

Two unrecorded anti-Semitic bulletins written and published anonymously during the 1949 Easter season. In "Christian Rejoicing - - Judaistic Sorrow and Plotting," the author contrasts "We of the Adamic, Caucasian Christian Civilization, predestined by God to have within us the Divine Spark which does not accept and react to the Dynamic of Jesus the Christ, that Caucasian of Galilee," with the conniving Jews. Excerpts from the diatribe are worth quoting in full:

"This Satanic Tolerance Stuff, this Slimy Venom of this Oriental Plot of the Sadducees of Today which Goes Forth as from the Mouth of Christ to Dull, Numb, and Befuddle Christian America, should be Stopped. Truly, Christian Religion, as the Jews have Doctored it up, is an Opiate to the People of America.

This Slimy, Treacherous Scheme of Judaising us into a Hell of their Planning, will Succeed unless Christians Act like Christians and Save Christianity. Shall Christians Act like Mortimer Snerds and Charley McCartheys, Inanely Mouthing Judaized Platitudes of Supposed Christian Concepts."



64.) Green, G. F. (edited by). The International Jew: "The World's Foremost Problem". New Barnet, Herts, England: G. F. Green, 1949. \$125

An abridgement of Henry Ford's four-volume *The International Jew*, in which G. F. Green, editor of the British *Independent Nationalist*, contributes a foreword and a brief chapter titled "Henry Ford - The Man." Gerald L. K. Smith later used Green's edition to issue his own abridgement and Edward Warwick Neville based his *An Introduction to the Protocols. Taken from Henry Ford's Book The International Jew* (195-?) on chapter six of Green's edition. Later editions of Smith's edition removed his introduction and substituted Green's foreword and the Henry Ford chapter (see Singerman). This copy with the presumed distribution stamp of Marilyn Allen, the Salt Lake City extreme rightist who distributed voluminous amonts of anti-Semitic propaganda.

The Patriotic Tract Society was directed by Smith protege, Donald Lohbeck, and mirrored the propaganda efforts of Swedish anti-Semite, Einer Åberg.



Smith accuses Jews of creating and sustaining Communism, which he describes as the "politics of the anti-Christ." Lists of Communistic Jews are presented along with "evidence" from a variety of sources. Also included are caricatures of Jewish revolutionaries originally published from cartoons by Otto von Kursell in *The Gravediggers of Russia* (1921). Other copies of this pamphlet bear a Detroit address. Copies were distributed by Smith's devoted office manager, Donald Lohbeck.

Smith concludes with a warning: "If the Jewish lobby is able to high-pressure our Congress into a program of direct action against the Arabs in the Middle East in support of the aggressive campaign of the Zionist Jews to establish an enlarged satellite empire, a wave of what the Jews call anti-Semitism will move across this Nation in tornadic form with catastrophic results."

The Christian Patriots Crusade was founded in 1956 by Forrest Allen Mann, Jr. (1936-2019) as the American Christian Patriots Party. Mann published a newsletter called "The Revere," led a small Klan group, and consorted with many prominent racists and nationalists during the 1950s, including Lyrl Clark van Hyning, Eustace Mullins, Ed Fields, J. B. Stoner, Joseph Beauharnais, etc. When the National States Rights Party was founded in 1958, Mann became the chairman of the Illinois branch. He was under constant FBI surveillance until 1960 when the CPC appears to have disbanded. Included in this small, but significant, collection are two issues of "The Revere" (Vol. 4, No. 10 and Vol. 5, No. 1) and three handbills: Exposing the Enemy, Freedom or Jewish Tyranny?, and Death to the Traitors: Communism and Race-Mixing Are JEWISH. 69.) A group of anti-Semitic publications by The Patriot. n.p.: n.p., [195-]. \$350

In the late 1950s/early 1960s a stream of anti-Semitic & racist pamphlets and cartoons were written and published by anonymous figure named "The Patriot", who remains undoxed today.

In *Christian Brotherhood*, he contends: "The cunning Jewish wolves are using Brotherhood as sheep's clothing to disguise their deadly infiltration into the ranks of Christ's sheep (to whom the Jews tolerantly refer as 'stupid goy cattle' and 'idolators'!)."

In *What They Are Saying*, he provides a slew of excerpts from the "private Pharisaic Press to learn what they are whispering behind our backs."

In *You and Your Children*, he bemoans the rise in juvenile delinquency due to the emasculation of fathers and the destruction of the traditional family, by Communist Jews who promote miscegenation, "Negro jungle throbbings," and modernism.

In the *Wisdom of the Sages*, he reminds readers what the "greatest thinkers, philosophers, and leaders of the last two thousand years" have to say about the Pharisaic Jews.

And in *The Low Man in the New Order*, he claims that farmers, once fiercely independent and proud, are now being forced to "abandon our farms and seek employment as rootless, propertyless city proletariat, powerless non-entities meekly subject on the one side to pitiless alien capitalists, and on the other side to merciless alien labor czars of the same unChristian world enslavement conspiracy."

Each pamphlet is one sheet folded, one with cover illustration. Some creasing, light wear. All Patriot propaganda scarce. (10039)



70.) [Purported letter from a NYC Jew, J. W. Pealer, Jr. to an anti-Semitic Southerner named Forest Sammons]. n.p.: n.p., [195-?]. \$150

A strange piece of anti-Semitic propaganda in the form of a purported letter from a NYC Jew named J. W. Pealer, Jr. to Forest Sammons (1895-1954) of Huntington, WV. The letter begins by addressing Sammons as a "Heine Bastard" and follows from there insulting Sammons and Southerners in a profanity-laced tirade. It concludes with a curse: "In a moment, DEATH PRAYERS, FROM THE MYS-TIC CABALA will be said against you, your wife, and damn stinken brat BASTARDS of children... To hell, with you, you filthy son of a bitch, THE JEWS have destroyed over 150 races, and nations who abused them. So the blackest of misfortune to you and yours, you dirty filthy Goy bastard."

Following the letter is an unsigned reply that swears to the veracity of the letter and the consequences of the Jewish curse: "This tender token of Talmudic 'tolerance' and Pharisaic 'brotherhood', sent to a wealthy contractor, bank director, and coal mine operator [Sammons], who died a violent death, is absolutely authenic [sic] being typed from the pencil-printed original, with original emphasis and errors." It goes on to warn, "We befuddled Gentiles had better soon wise up to this fratricidal strife which the Pharisaic Conspirators are stirring up for the sole purpose of enslaving and decimating the goyim of both and South and the rest of our nation."

Sammons was a minor figure in the anti-Semitic far right who led the one-man West Virginia Anti-Communist League from his home in Huntington, WV. He stamped all of his correspondence, "Stop the Jew!" and was known for distributing copies of the spurious Benjamin Franklin quote concerning the Jews. As the letter intimates, Sammons was a wealthy contractor, and although he died in 1954 at age 59, there is no evidence that he met a "violent death." See Roy, pgs. 76-78.

A letter purportedly written by Rabbi Joseph S. Shubow of Temple B'nai Moshe in Brighton, MA, to William Zukerman, an anti-Zionist Jew who published the Jewish Newsletter, which was affiliated with the American Council of Judaism. Shubow describes the publication as a "self-hating gutter rag, where a contemptible cad tries to make it appear that Jews are nothing and nobodies and will soon disappear anyhow." He goes on to vilify Zukerman and curses him thusly: "God will surely strike you down and send upon you all the makkos and plagues which were prepared for a base, satanic creature like yourself. A thousand curses upon you!

An unsigned reply characterizes Shubow's letter as a "'brotherly-love' letter" that exhibits "all the pent-up hatred of the mass of Jewry toward the goyim [now] heaped upon their own flesh-and-blood who show signs of breaking away from the pirate band."

The letter is similar in style, language and format to the spurious Pealer/Sammons letter (see item 70) and appears to have been concocted by the same individual or group providing an unexplored research opportunity for those studying the anti-Semitic fringe.


The Christian Anti-Jewish Party was a collaboration between Stoner and Edward Fields after their membership in the Columbians. They would go on to found the United White Party in 1957 and the National States Rights Party in 1958. Both remained committed lifelong extreme right activists (Fields, who turns 90 this year, still distributes propaganda from his home in Marietta, GA).



73.) Schreiber, Charles J. Interfaith: One Aspect of World Government. Reseda, California: Christian Patriotic Rally, [1954]. SOLD

Schreiber believes that Christianity is being diluted, absorbed, and endangered by the promotion of interfaith (i.e., Judeo-Christian) cooperation promoted by groups such as the United Israel World Union in furtherance of a Zionist one-world government. He discusses the emergence of "Cabalist Jewish Messiahs", such as Moses Guibbory, author of The Bible in the Hands of Its Creator, "which can be called the Bible of Cabalist Luciferians of our time...[and] suited for the teachings and practice of Satanic occultism" (p. 2). He reprints the United Israel World-Union's Declaration of Principles and contrasts it with a Christian Declaration of Principles affirming "our invincible faith in the Divinity of Christ and the Holy Trinity" (p. 7). He concludes by asking, "Shall we stand by motionless watching the Cross of Jesus thrown aside to be replaced by the triangular Zionist Star of David?"

74.) McGinley, Conde (ed.). Common Sense (109 issues). Union, N.J.: Christian Educational Association, 1954-1972. \$750

A substantial, but far from complete, run of *Common Sense*, one of the most enduring and important far right newspapers of the 20th century. Founded in 1947 by Conde McGinley, the paper began a year earlier as *Think* (also *The Think* and *Think Weekly*), and described itself as "the nation's anti-Communist newspaper." However, early on the paper became shrill in its denunciation of Jews and Zionism and by 1954 McGinley and Common Sense came under the scrutiny of the Velde Committee, Committee on Un-American Activities, in their *Preliminary Report on Neo-Fascist and Hate Groups*, which determined that the paper's "patriotic claims provide poor disguise, however, for some of the most vitriolic hate propaganda ever to come to the attention of the committee" (p. 10). Many prominent anti-Semites contributed to the paper including Eustace Mullins, Fred Weiss, Elizabeth Dilling, Revilo P. Oliver, Eugene Sanctuary, Charles B. Hudson, Marilyn Allen, Lt. Gen. P. A. del Valle (who later became President of Christian Educational Association), Don Bell, etc.

McGinley founded the Christian Educational Association in 1954 to publish *Common Sense* and other right wing pamphlets, and for a time one of its primary sources of income was Benjamin H. Freedman, a Jewish-born millionaire who'd converted to Christianity. McGinley closely collaborated with James Madole and the National Renaissance Party and for a time printed much of that group's propaganda. McGinley died in 1963 and editorship was passed to Katherine Littig who continued the paper until 1972 when she left for Canada to join the Catholic community of St. Jovite. Many supporters believed COINTELPRO was behind the paper's dissolution (Bolton, p. 339).





A pamphlet from the South African anti-Communist, Johan Schoeman, in which he reprints in Afrikaans the last letter written by Hermann Goring to Winston Churchill and includes an English language version of his "Who Is Behind Communism? (A Very Small Essay on the Leprosy Miscalled Communism)." The 'who' is the Jew who has "no binding ethical and spiritual laws, [and] is quite right in his adoption of communism, or any ism for that matter, that will assist him in surviving in terms of the natural law of the survival of the fittest - very often the fittest being the most easily adaptable, like the scum, which floats on top in terms in terms of the law of the moral, or rather immoral, gravity." He implores the reader to read and re-read the Protocols and provides a list of far right resources at the end. Schoeman was the son of Gen. Hendrik J. Schoeman who fought in the Anglo-Boer war and the grand-son of Stephanus Schoeman, second President of the South African Republic.

77.) [Mullins, Eustace]. Abominable Yet True. Chicago: Women's Voice, [1952]. \$150

The purported transcript of a speech given by Rabbi Emanuel Rabinovich before the Emergency Council of European Rabbis in Budapest, January 12, 1952. In the speech, the Rabbi outlines the Jewish plot to foment a new world war that will allow the Jews to take their "rightful place in the world, with every Jew a King and every Gentile a slave!" The rabbi goes on to describe the plan to eradicate the white race through miscegenation:

"The white woman must co-habit with members of the dark races, the white men with the black women. Thus the white race will disappear, for mixing the dark with the white means the end of the white man, and our most dangerous enemy will become only a memory. We shall embark upon an era of ten thousand years of peace and plenty, the Pax Judaica, and our race will rule undisputed over the earth. Our superior intelligence will easily enable us to retain mastery over a world of dark peoples."

The forgery was concocted by Eustace Mullins and published in the May 1952 issue of Lyrl Clark van Hyning's newspaper, *Women's Voice*, who then issued this offprint. Conde McGinley reprinted it in his newspaper *Common Sense* followed decades later by neo-Nazi George Dietz who reprinted the transcript in the January 1978 issue of *Liberty Bell* under the title, "Exposing the Conspiracy: A Rabbi Speaks." A fascinating, if spurious, document employing many of



Although her father-in-law and husband were Masons, she claimed to have written 35 articles exposing Freemasonry's evil & destructive elements. van Hyning was one of the founders of the anti-war organization, We, the Mothers, Mobilize for America, and editor of the *Women's Voice*, a widely read nationalist publication.

A broadside reprinting an article by Eustace Mullins originally published in Lyrl Clark van Hyning's *Women's Voice*, the organ of her We, the Mothers, Mobilize for America organization. Mullins makes an impassioned plea against sending American soldiers to die in the Zionist-Communist United Nations wars. Instead, he maintains that the "lives of our American boys could be saved if fifty international Jewish bankers could meet a speedy and well-deserved death. He continues, "If the United Nations building must survive, let it become a crypt for the Satanic Jews who day and night plot the massacre of the flower of American youth."



80.) Edmondson, Robert Edward. "I Testify": Amazing Memoir-Exposure of International Secret War-Plotting. [Bend, Ore.]: Published by the author, 1954. Second printing. \$125

A disjointed memoir by the prolific anti-Semitic propagandist on his fight against organized Jewry. The book is essentially a compilation of material culled from Edmondson's bulletin, from many of the legal proceedings against him, from speeches before various right wing groups, and from articles/speeches by other anti-Semitic figures such as H. H. Beamish and Adrien Arcand. Also included are the obligatory statements from Jews implicating themselves in their treachery, and quotes from famous figures on the Jews.

Robert Edward Edmondson (1872-1959) was a journalist, editor, financial writer, and investment analyst who established the Edmondson Economic Service in 1934 to focus on publicizing Jewish financial and political subversion through a weekly bulletin. He claimed to have distributed five million copies of his bulletin in only two years of operation. In 1939 he moved his operation to Stoddartsville, Pennsylvania, then Scranton before moving to the west coast. He died in Bend, Oregon in 1959. He was a defendant in the Great Sedition Trial of 1944.

81.) X. Y. Z. (Frederick C. F. Weiss). Kto Kovo (Who-Kills-Whom?): An Analysis of the World Power Struggle. New York: Le Blanc Publications, [1955]. \$350

The second pamphlet in a three-part series on Russia written by Francis Parker Yockey mentor and collaborator Frederick C. F. Weiss, potentially with significant input from Yockey (Bolton, p. 323). The pamphlet maintains that Russia, through Stalin's Great Purges, extinguished Jewish-Bolshevism and restored the true Russian soul as developed by Dostoevsky (the characteristics of which were detailed in Russia, Part I). Conversely, the West is described as managed by feckless "idiots" who have succumbed to the Jewish Consensus and exchanged Nationalism for Nihilism.

In November 1955, H. Keith Thompson (who developed the Russia thesis with Weiss and Yockey) printed 3,500 copies of the pamphlet at his father's printing firm, Cooper Forms, where he was manager. Weiss allegedly had another 5,000 copies printed in December due to high demand. The pamphlet was primarily distributed by James Madole's National Renaissance Party. Originally planned as a four-part series to be published as a book, part III was published in 1956 and ended on a final note.

A two-part article written by Kenneth Goff and initially published in the Sept. and Oct. 1955 issues of Gerald Winrod's *Defender* magazine. Goff describes the Talmud as the "filthiest rot ever put into human language" and decries its influence over the Jewish people, and increasingly, over American Gentile culture. He then discusses the disproportionate Jewish influence in the media and political institutions and accuses Jews of fomenting racial strife. A particularly strident attack, but not atypical for Goff or the standard fare published by Winrod.



The author documents the preponderance of Jews in domestic Communist groups and the history of Jewish involvement in International Communism to counter the propaganda of "professional Jewish 'defense' organizations such as the Anti-Defamation League of B'nai B'rith and the American Jewish Congress [who] have been frantically raising the cry that American Jews are as anti-Communist as their gentiel countrymen, and that Judaism itself actually represents a strong moral and social bulwark against Soviet Bolshevism" (p. 4). "George Pickney" is believed to be a pseudonym. One of the most widely circulated pamphlets by Conde McGinley's Christian Educational Association.

A virtually unobtainable racist and anti-Semitic publication concocted by Eustace Mullins, but issued under the pseudonym George Thomas Adams for the fictitious Southern States Press Association. The newsletter is a compilation of horrific news clippings of Black crime against White women and children with illustrations of Jewish caricatures and satirically captioned photographs of Africans and apes. In one doctored photograph, a small white toddler sits at the feet of a group of Mau Maus with the caption: "Mau Mau boys in the jungle cities of the north capture a young white girl for sex." Mullins can't help but insert some disparaging editorializing, such as the following:

"DID YOU KNOW THAT -- government policy for minorities is created by sex perverts who salivate freely at the thought of little white girls being brutally ravished by hulking Negro thugs? These tittering nancies, classic types of simpering homosexuals, fled like butterflies from the State Dept. after Sen. McCarthy discovered that any of them had Communist boy friends. These sex perverts have chosen Eisenhower as their spiritual leader, because his shining bald pate represents a phallic symbol to them."

In a note to Yockey collaborator, Frederick Weiss, Mullins wrote, "This is my masterpiece" (see FBI file on Mullins). The ADL turned a copy over to the FBI who declined to investigate. This copy from the estate of Mullins,

The final panel features a hammer & sickle in the upper corner. Also included is an article by the Salt Lake City anti-Semite Marilyn Allen titled "Pussyfooting Preachers," as well as a few shorter items on the Jews as the Synagogue of Satan, a quote by Joseph Stalin, and the Free Press' mission to educate Americans on Communism. According to Singerman, this was one of the earliest iterations of the cartoon.



A flyer featuring a five panel cartoon depicting Uncle Sam pushing a Native American over a cliff and then being pushed himself by a triumphant Jew. The last panel shows the Jew holding pennants featuring the hammer & sickle, Star of David, and the U.N. logo. Although we have been unable to trace the cartoon's original publication, the United States Holocaust Museum claims that it was first published in 1909 in their description of a 1942 Nazi poster that featured it. The National Renaissance Party, the first post-war neo-Nazi organization in the U.S., published a two-sided flyer in the 1960s titled, "Have Jews Taken Over the United States" with the same cartoon (see no. 89 below), although the Jew in the last panel was holding no pennants, but instead had a Star of David over his head. This copy came from the estate of anti-Semite and Federal Reserve researcher, Eustace Mullins, and was included with other publications he was involved in.

One of a number of variants of the oft-printed cartoon depicting Uncle Sam pushing a Native American over a cliff and then befalling the same fate at the hands of a Jew. The verso features an essay presumably written by National Renaissance Party leader James Madole titled "Have Jews Taken Over the United States?" It accuses the Jews of smearing American patriots, undermining Christian traditions such as Christmas, promoting Zionism, and subverting racial segregation through front organizations that promote miscegenation.

In Who Belongs to Hate Groups, Petrov reprints 24 excerpts from the Talmud as "proof" of the Jews' desire to murder and enslave Gentiles. Further excerpts from various far right publications, including his own newspaper, "Borba," document the inextricable link between Judaism and Communism. A number of anti-Semitic cartoons are included. A single sheet folded (8 ½" x 7"), 4 p., illus. Distribution stamp of fellow anti-Semitic propagandist Joseph Dilys at the fold, else Fine.

A compilation of anti-Semitic passages from Alerte, Lady Queenboro's *Occult Theocrasy* (see item <u>14</u>), and "Nasche Obschtschee Delo," as well as a chart of the Masonic Pyramid, and the oft-reprinted cartoon, History of the United States, in which Uncle Sam pushes a Native American off a cliff only to meet the same fate by a Jew holding Communist, internationalist and Zionist pendants (see items <u>87-89</u>). A supplement of the relatively short-lived organ of the British National Party, which was founded in 1960 and joined Colin Jordan's White Defence League with John Bean's National Labour Party. The focus of this supplement was the national socialist movement's outrage over the capture of Adolf Eichmann by the Mossad and his subsequent trial in Israel. There is also coverage of the murder of two British soldiers in Palestine at the hands of the Jewish terrorist organization, Irgun, and of the murder of Swedish Count Bernadotte by the Stern Gang. Other content refutes the official holocaust narrative and accuses Jews of declaring war on Germany prior to WWII. The rear cover features an article on the massacre of Arabs by Jews by Peter Ling.



No author listed, but originally appeared in the Jan. 1974 issue of Schiffner's *Prophetic Herald* newsletter. It was then published as a pamphlet by both Schiffner and James K. Warner's New Christian Crusade Church (this copy), which he founded in 1971 following his earlier conversion to Identity. 93.) Peck, Alan L. The Epistle: Newsletter of Saint Paul Lutheran Church (8 issues). Sanford, Michigan: Saint Paul Lutheran Church, 1962-64. SOLD

Eight issues of the mimeographed newsletter issued by obscure Lutheran pastor, Alan L. Peck, who uses his publication to criticize Jews, integration, Communism and Christian liberals, report on church activity, and discuss doctrinal schisms in the Lutheran church. The vol. 3, no. 6 issue is titled The Great Lie! and contends that the Jews are modern-day Pharisees, that Judaism is based on the Talmud, and that the Jews are not God's chosen people. Peck further states: "The avowed aim of the Jewish faith is to to rule the world so that they can obliterate completely the church of Jesus Christ and all Christians" (p. 3-4). In vol. 6, no. 2, Peck discusses racial segregation and contends that whites, Negroes and God don't want race-mixing but that Satan and the Jewish-led NAACP do.

94.) [Burros, Dan]. Communism Is Jewish. New York: Dan Burros, [196-]. \$650


A virtually unobtainable flyer - and one seething of self-hatred - presumably designed, printed and distributed by Jewish-born Nazi Dan Burros in the early 1960s after he returned to NYC following his defection from the American Nazi Party.

The flyer is a crude compilation of anti-Semitic illustrations, slogans & swastikas including 24 caricatures of prominent Russian Jews originally published from cartoons by Otto von Kursell in *The Gravediggers of Russia* (The German People's Publishing House, 1921). Also featured is an illustration showing two hands adorned with swastika cufflinks holding a Jewish specimen called 'Judaeococcus Virulans', "the Super-Microbe of World Sickness." One of the most virulent pieces of anti-Semitic propaganda incredibly produced by Burros was particularly vocal about his hatred of Jews and would frequently discuss novel means of torturing or killing them with anyone who would listen. This included John McCandlish Phillips, a young reporter from *The New York Times*, who after listening to Burros ramble upon about Naziism and Jews, quietly asked how he reconciled his extremist viewpoint with his own Jewish ancestry.

Born into a Jewish family in the Bronx in 1957, Daniel Burros became fascinated by militaria, especially the German Army, and joined the U.S. Army in 1955, although he was discharged two years later after a couple of half-hearted suicide attempts. Soon after, he became involved with George Lincoln Rockwell's American Nazi Party and later, the National Renaissance Party, the fledgling Odinist movement and the Ku Klux Klan. He founded his own small group with fellow ex-ANP member and future George Lincoln Rockwell assassin, John Patler, called the American National Party and edited a small format magazine called *Kill!* and a tabloid called *The Free American*. After Phillips' front page story broke in Oct. 1965, Burros, in a moment of distraught frenzy, shot himself in the chest and head at the Reading, Pennsylvania, home of fellow Klansman, Roy Frankhouser. His posthumous biography, *One More Victim: The Life and Death of an American-Jewish Nazi* (1967), was written by Phillips' bosses, A. N.

Rosenthal & Arthur Gelb, and his life was the basis for the 2001 film, The Believer, starring Ryan Gosling.




One of the most notorious comic books ever issued, in which Arlington milkman Lew Cor transforms into Whiteman by uttering the secret words 'Lien Geis!' ('Seig Heil' spelled backwards). ('Lew Cor' was the one-time pseudonym of American Nazi Party founder George Lincoln Rockwell ['Roc wel' spelled backwards].) In his swastika adorned outfit, Whiteman battles a group of black arsonists, the Jew from Outer Space, and Supercoon, although the Jew from Outer Space escapes while Whiteman is busy trying to suppress the black crime rate on Earth.

The comic book was the brainchild of American Nazi Party stalwart John Patler who was responsible for both the story and illustrations. The book was distributed by the Dallas branch of the ANP, which was run by married members Robert and Mary Surrey. In 1966, Rockwell moved the Party's business operations from party headquarters in Arlington to Dallas due to the seizure of its assets by the IRS in late 1965. So it's likely that the comic book was issued in 1966 instead of the 1965 date typically cited. Adverts for other Party paraphernalia include a 'Boat Ticket to Africa', *Stormtrooper* magazine, and swastika armbands, all available from the Dallas branch.

96.) Boating Not Busing [with] Boat Ticket to Africa. Baltimore: National Socialist White People's Party, [197-]. SOLD

An anti-busing flyer courtesy of the Baltimore chapter of the National Socialist White People's Party paired with the notorious Boat Ticket to Africa, which the American Nazi Party began producing during the 1960s. The flyer enumerates the many reasons why busing blacks to white schools is detrimental to the white race and suggests sending them to Africa instead. The Jews and Washington bureaucrats are accused of fomenting the crisis while sending their kids to private schools. The verso includes books and other items distributed by the Party.


A one-way Boat Ticket to Africa aboard Coon-ard Lines is stapled to the top of the flyer. The boat is described as a "Cadillac with fins," with "plenty of wine, marijuana, heroine [sic], bananas," an unguarded "chicken-coop and watermellon [sic] patch," a "barrel of axle grease for hair," and "framed picture of Eleanor Roosevelt and Harry Golden." Entertainment includes Martin Luther Coon's jazz band. Passengers are advised to drop their ticket stub in a box on board for the chance to win a life-jacket from "big-hearted Izzy Pilebaum" should the boat sink. The verso features a coupon for "Instant Nigger," for "liberal, White 'peace creeps', race-mixers and nigger-loves...who would like to join the COON-ARD Lines Cruise, but can't do it and must endure life in a white town without any nigger friends." We've seen variations of this ticket later reprinted by the Ku Klux Klan.

97.) Winrod, Gordon (ed.). The Winrod Letter, Issue no. 88, April, 1969. Gainesville, Mo.: Gordon Winrod, 1969. \$75

In this issue of *The Winrod Letter*, Gordon Winrod blames the Jews for the Vietnam War and claims: "Just as much as the human body needs daily food, so much does the lust of the Jews to kill Christians require satiety" (p. 2). He then includes excerpts from the Congressional Record of March 25, 1969, in which two Congressmen, Paul Findley and Tim Lee Carter, entered the names of the 31,379 American soldiers that had thus far been killed in Vietnam. He then quotes from issue 74 of The Winrod Letter on the solution to ending the war: "Let all citizens in these United States, in each County where they live, all do their part in KILLING ALL JEWS IN THEIR RESPECTIVE COUNTIES. This could easily be done in one day. On that same day the war in Vietnam will end" (p. 3). Other content includes an article on the proposal of an abortion bill in New Mexico that would allow "antichristian Jew murderers (so-called doctors) to legally kill babies!" (p. 4); and book reviews of two far right figures, Charles Cotten and Father Coughlin, who Winrod claims has sold out to the Jews.

An anonymously written and published report ("For Internal Use Only") explaining Judaism as Pharisaism and Judaism, Communism as the political arm of Judaism, and Jewish involvement in the civil rights and black power movements, hippies and SDS, the drug trade, pornography, and Jewish subversion of Christian fundamentalism. The report concludes with ways to counter the Jewish "problem," a selection of famous quotations on the Jews, and a list of "agitators of yesterday and today."



99.) The Sordid Story of Document 8795. n.p.: n.p., [1961]. \$45

An anonymous two-sided flyer alleging the suppression of Document 8795 in the National Archives. The document, which is reproduced on the verso, contains a letter dated Dec. 1, 1920 from J. Edgar Hoover to Undersecretary of State W. L. Hurley acknowledging receipt of dispatch no. 62 from the American Consul at Reval. This dispatch contained the names of "disseminators of Bolshevik propaganda," and included future Supreme Court justice Felix Frankfurter. Hoover once referred to Frankfurter as the "most dangerous man in America" for his left-leaning sympathies. The flyer contends that a researcher attempted to access the document in March 1961. Not only was his request denied, but the document was removed from the files and the microfilm cut from the roll. Following photostat requests from numerous Congressman, the FBI was sent to their offices to persuade them to reconsider.





100.) Gale, Rev. William P. [Racial and National] Identity. n.p.: n.p., [ca. 1975]. \$65

Two William Potter Gale articles originally printed in his quarterly, *Identity*, on the Biblical, anthropological, and historical origins of the white race. Gale contends that the Bible contains the history of the white race and traces the lineage of white Americans to the Biblical tribes. The Jews on the other hand are descended from Cain, and thus from Satan. After the death of Wesley Swift, Gale was the foremost expositor of racial Identitarianism in the U.S. and was deeply involved in the Posse Comitatus, sovereign citizens and militia movements. A number of editions of this pamphlet were issued in the mid-1970s by a variety of Christian Identity churches (see Singerman for the only comparative description).

101.) Anonymous (David Hoggan) . The Myth of the Six Million. Los Angeles: The Noontide Press, 1969. First Edition. SOLD

One of the first works of Holocaust denial/revisionism written in 1960 by UC Berkeley history professor, David Hoggan, but not published until 1969 when Willis Carto published it anonymously through his Noontide Press. Hoggan sued Carto for publishing the work without his permission and a lawsuit was settled in 1973. The book counters the claim that six million Jews died in the Holocaust and contends that the German treatment of European Jews has been subject to "a deliberate defamation and falsification conspiracy on an unprecedented scale" (p. 104). Hoggan's research was influential on Richard Harwood's *Did Six Million Really Die* (1974). Carto contributes an introduction under his pseudonym E. L. Anderson. An Appendix includes five articles on the topic originally published in the *American Mercury*, which Carto owned at the time. One advert for Francis Parker Yockey's *Imperium*.

Hoggan had previously written his Harvard dissertation on British and Polish culpability for WWII through which he convinced the eminent historian and fellow revisionist Harry Elmer Barnes that Hitler had not desired war. Barnes encouraged Hoggan to publish his dissertation, which he revised as a more strident attack on Britain and Poland and in further defense of Germany. The book was published in Germany in 1961 as *Der erzwungene Krieg* (1961), but wasn't published in English for 28 years when it was issued by Carto's Institute for Historical Review as *The Forced War: When Peaceful Revision Failed* (1989).



102.) Butz, A. R. The Hoax of the Twentieth Century. Torrance, California: The Noontide Press, 1979. Third U.S. printing. \$95 (ON HOLD)

Widely considered to be the definitive work of Holocaust revisionism, *The Hoax of the Twentieth Century* argues that no mass extermination of Jews took place, but was instead an orchestrated propaganda campaign by Zionists and their Jew-Communist bedfellows. Butz's book was feted by revisionists and Holocaust deniers upon its release, but was refuted by Jewish groups and establishment historians.

Butz researched and wrote the book while an associate professor of electrical and computer engineering at Northwestern Univ. The book was first published in England in 1976 by the far right Historical Review Press founded by Anthony Hancock. Willis Carto published the first U.S. edition under his Noontide imprint the following year with later editions published by the Institute for Historical Review. The book became a target of Amazon's 2017 purge of revisionist and extreme right titles and is now banned from being sold on that site.

103.) Stimely, Keith. \$50,000 Auschwitz Reward Unclaimed; "Gas Chambers" Myth Continues to Crumble (IHR Special Report). Torrance, California: Institute for Historical Review, [1983]. \$50

A special report from the Institute for Historical Review on their provocative publicity campaign, which began in 1979 when they offered \$50,000 to anyone who could prove that Jews were gassed during the Holocaust. In a long update, IHR director Keith Stimely profiles some of the unsuccessful claimants who either failed to provide irrefutable proof or, like Simon Wiesenthal, refused to accept the IHR's terms. Stimely mentions the case brought against the IHR by "Professional survivor" Mel Mermelstein who sued the IHR in 1981. Mermelstein ultimately prevailed and was awarded a \$90,000 settlement in 1985. He and the IHR sued and countersued each other throughout most of the 1980s and into the 1990s. Also included is a long unsigned article, "The Crumbling of a Myth," on the current state of revisionism, as well as "A Worldwide Bibliography of 'Holocaust' Revisionism."




104.) [Gillespie, William]. Dietrich Eckart. n.p.: n.p., [197-]. \$50

The scarce first edition of William Gillespie's favorable biography of Dietrich Eckart, the German poet and journalist and a founding member of the German Workers' Party, the precursor to the NSDAP. He was an influential National Socialist ideologue, crusading anti-Semite, and a mentor to a young Adolf Hitler who dedicated *Mein Kampf* to him. Gillespie chronicles Eckart's neglect among Nazi/Hitler historians and refers to him as "the forgotten man." The pamphlet includes an Author's Note, a short biography, and a section on Eckart's role as a propagandist and politician (which includes his influence on Hitler). Footnotes, a bibliography, and original source material is included in the rear.

Gillespie published a second, revised edition in 1976 under his name and from his home in Houston, TX. Why he published this first edition anonymously is unknown. He was also the author of *Dietrich Eckart: A Bibliographical Guide and Index* (1976) and *Who Was This Man and Why Did Adolf Hitler Dedicate "Mein Kampf" to His Memory?: Dietrich Eckart - An Introduction* (1979).


A lengthy, if somewhat disjointed, account of the life of Gordon Kahl, the North Dakota farmer, tax protestor, and Posse Comitatus member, who was involved in two shootouts in 1983 with federal and local agents resulting in the death of Kahl and three agents. His friend and fellow tax protestor Len Martin wrote numerous pamphlets memorializing Kahl and explaining the Jewish-Masonic plot to destroy patriotic sovereign citizens. Martin was the operator of a right wing Christian school and the North Dakota representative of the Farmers Liberation Army (see Levitas, p. 195).

The scarce first printing of the notorious comic book issued by William Pierce's National Alliance in 1993. Presumably aimed at converting a younger generation of white nationalists, the story features the eponymous 'White Will' who must battle "uncivilized" & militant blacks, the Jewish students who manipulate them, 'wiggers', and a craven administration at his high school. Through physical violence, intellectual nourishment from a National Alliance representative (a fellow student's father and thinly disguised William Pierce), and an alliance with racially conscious blacks who throw off their student Jewish overlords, Will organizes some of the white student body, sabotages a "Peace and Brotherhood" rally, and swells the ranks of the National Alliance.
